

MINUTE OF THE MEETING HELD ON 20/11/2014

A meeting was convened on 20/11/2014 at 1100 hrs to discuss about the collapsed bridge of Seba and other matters related to Trans-Arunachal Highway in the office chamber of Deputy Commissioner, Seppa.

The following were present in the meeting which is annexed at -'A'.

At the very outset, the Deputy Commissioner welcomed to all present in the meeting and briefed the purpose of meeting and begun discussion.

After thorough discussion, following decisions have been taken.

1. The Artha Construction/Sushee shall repair the collapsed bridge at Seba by 31/3/2015 at least for crossing of light motor vehicle. No heavy vehicle shall be allowed to cross through that bridge.

Action by : Sushee/Artha Constn, CO concerned.

2. Issue of Notice for replacement of permanent structures of the compensated from Minapahar to Lumdung and Sede to Pakro for immediate starting of works.

Action by: DLRSO and CO concerned

3. Shifting of electrical poles/water pipes from Seppa to Khodaso by 5/12/2014.

Action by: EEs, PHED & Electrical/CO concerned

4. Constitution of a committee under the chairmanship of concerned Circle Officers to verify the dumping ground especially in Pijerang and Pakke-Kessang circles. The place has to be identified in consultation with construction agency and local villagers.

Action by: District Admn/DLRSO

5. Issue of order for those whose claims are bogus by quoting not to disturb the ongoing works of TAH, failing which a case u/s 188 IPC will be registered.

Action by: Dist. Admn/DLRSO

6. Immediate start of alignment work from Sede to Pakro.

Action by: Artha Constn.

7. Left out compensation and local disputes shall be cleared by 30/11/2014 thereafter no claims for land/property from Bana to Seppa shall be entertained.

Action by: DLRSO/CO concerned

8. Maintenance of existing road from Bana to Hari bridge shall be completed by 31/12/2014, as the MORTH have already been provided fund for repair/maintenance of road.

Action by: Sushee

9. Immediate deployment of security personnel at Bana and their accommodation shall be provided by CO, Bana.

Action by : Supdt. of Police & CO, Bana

10. The DLRSO will prepare a schedule for clearing all the claims and objection after visiting the sites at Bana, Seppa, Lumdung, Pakke-kessang and other areas. A certificate has to be issued to the construction company regarding the clearance of any kind of claim.

Action by: SDO(S) & DLRSO

Lastly, the EKSWCO Chairman advised the Constn. Agencies, if any, untoward incident happens matter must be shared with them for amicable settlement from their end.

The meeting ended with vote of thanks by the chair.
