

MINUTES OF THE DISTRICT EXECUTIVE COMMITTEE MEETING HELD ON 29/09/2014.

A meeting of the District Executive Committee(DEC) chaired by the Deputy Commissioner, East Kameng District, Seppa was held on 29th Sept'2014 in the office chamber of the Deputy Commissioner, Seppa for examination and disposed off all pending relief cases.

The DDMO, while welcoming the house, highlighted the objectives behind to convene this meeting and presented pending cases of compensation for losses to houses, crops and animal due to natural calamities and Trans Arunachal highway cutting for consideration of relief assistance from 6th Aug'2013 till date.

While initiating the discussion on item wise damaged reports, the Deputy Commissioner cum Chairman of DEC, Sri Sandeep Kumar Singh, IAS, put forward the serial wise damage reports along with necessary Govt. guidelines and availability of fund etc to the house for examination and suggestion on individual damage reports for consideration of relief assistance.

After a threadbare discussion/ examination, the house unanimously recommended the necessary relief assistance as under along with the following suggestion.

i). Individual relief assistance as recommended by the house:-

3.	Agri-Land damage (By natural calamities)	59 Nos.	@Rs. 2,500/- per house
4.	Kutcha House damage (By landslide)	55 Nos.	@Rs. 3,000/- per house.(54) @Rs.15,000/- one house (01)
5.	Kutcha House damage (By Fire accident)	32 Nos.	@Rs.10,000/- per house
6.	Pucca house damage (By Fire accident)	05 Nos.	@Rs.30,000/- per house

ii) Suggestion of the house.

- 1) DAO to submit the crops and Agri-land damage reports followed by its photographs/video graphs and category wise land whether it is cultivated or non cultivated .
- 2) Crops damage due to cutting of TAH to be incurred from the Dist. Relief Committee fund Seppa.
- 3) All relief assistance for Bameng and C/Tajo Sub-Division to be disbursed through their end respectively and a disbursement copy be submitted to the Deputy Commissioner, Seppa.
- 4) Crop damages of respective Circle jurisdiction be assessed at circle level and its report be submitted to the concern ADC for further necessary action.
- 5) No individual FDR estimate be prepared by the EE(WRD) for onward submission to the Govt. without prior permission from the Deputy Commissioner, Seppa.
- 6) Fund to be earmarked for immediate restoration for clearance of road blockages and damage Log bridges etc and also for purchasing of some urgent necessary equipments within a limited amount.
- 7) Considering the need of a Rain-gauge by the DAO, Seppa , a Rain-gauge be purchased and issued to the DAO ,Seppa for recording day to day rainfall reports.
- 8) The reports for death of Mithuns have not been considered for relief assistance.
- 9) The payment of relief assistance be made through the respective Administrative Officers and individual Payment for Rs. 10,000/- and above be made by cheque.

The meeting ended with the vote of thanks extended by the DDMO cum Member Secy.(DEC),Seppa.


