

**MINUTES OF THE DISTRICT CONSULTATIVE COMMITTEE/
DISTRICT LEVEL REVIEW COMMITTEE MEETING HELD ON 9/12/2014**

The District Consultative Committee/District Level Review Committee held on 9/12/2014 at 10 am under the Chairmanship of the Deputy Commissioner, Seppa in the Conference room of DC's office.

The Chief Manager, Lead Bank stated that the DCC/DLRC meeting was not conducted regularly in the district, henceforth meeting shall be conducted quarterly and next meeting shall be scheduled on February'2015. He requested all the members to be present in the next meeting along with the progress report of various schemes undertaken by their department.

After long discussion on the matters, following decisions have been taken.

1. Maintain credit - deposit ratio of the district as per RBI guideline.

2. Constitution of a Recovery Team for recovery of loan from the beneficiaries provided under various Govt. Sponsored Schemes. Initiatives shall be taken by Branch Managers.

3. The concerned HoDs shall ensure for immediate selection of 5 beneficiaries each from every Block (those having Land Possession Certificate) by deploying their Field Staff to open Kisan Credit Card (KCC) and pursue the matter with the Branch Managers.

4. Immediate submission of list of selected beneficiaries under Prime Minister Employment Generation Programme for the year 2014-15.

5. Recovery of bank loan to various beneficiaries in the district is poor. Process of Bakijai cases be started immediately for disposal of the cases.

6. Opening/installation of Kiosk Bank at Bana, Chayangtajo & Bameng where basic infrastructures are available.

Action by :- BDOs, Bana/Chayangtajo /Bameng after discussing with the Branch Manager, SBI

7. Timely conduct of Financial Literacy Programme by the Banks.

8. Financial Inclusion under Jan Dhan Yojna – account opening under MGNREGA.

Action by : CM, LB, Bomdila & BMs, SBI/CBI/ Apex Bank.

9. Opening of Rural Sector Educational Training Institute (RSETI) at Seppa.

A district level coordination meeting of East Kameng District was held at Kameng Hall, DC's Office, Seppa on 17-8-2014. Chaired by the Deputy Commissioner, Mr. Sandeep Kumar Singh, IAS, the meeting was attended by Mr. Kumar Waii, Hon'ble Minister RWD, Mr. Tapuk Taku, Hon'ble Parliamentary Secretary (Tax & Excise), Mrs. Karya Bagang, Hon'ble Parliamentary Secretary (Social Welfare, Women & Child Development), Mr. Mama Natung, Hon'ble Parliamentary Secretary (Tourism), Mrs. Meyuk Cheda, Zilla Parishad Chairperson, East Kameng district, Administrative Officers, all Heads Of Departments and Panchayat Members. A list of the participants is attached at Annexure 'A'.

The objective of the meeting was to ascertain areas of concern in the spheres of administration, governance and development in the district and to determine ameliorative strategies. Comprehensive discussions by all concerned identified the following points of intervention.

1. POLICE/LAW AND ORDER

- a) As per the records, the numbers of criminal cases have come down. But off the record, cases of intimidation and extortion are still being reported.
- b) FIRs can be filed only at the police stations. Hence they should be addressed to the Officer-in-Charge of the Police Stations at Seppa, Chayantajo and Seijosa.
- c) **There are only 7 (seven) Sub-Inspectors posted in the district against the sanctioned post of 14 (fourteen). This hampers investigation and other duties and should be addressed at the earliest.**
- d) It was proposed that there should not be home posting for police personnel to ensure impartiality of stance and diligent discharge of duty.

2. EDUCATION

- a) **The district suffers from the chronic problem of teachers being released without relievers taking up their assignments.**
- b) Two higher secondary schools, namely GHSS Chayantajo and GHSS Pampoli are totally bereft of Senior Teachers due to non-sanctioning of the same.
- c) The shortage of teachers comes to 15 (fifteen) Senior Teachers and 96 (ninety six) Junior Teachers.
- d) Absenteeism of teachers is a serious issue, especially in the rural areas. This in turn leads to non-enrolment of students.
- e) Non-enrolment of children in most village schools has almost rendered the schools defunct and the teachers idle.
- f) One of the contributing factors towards the problems of the schools in the outpost is the low level of awareness among the parents and the members of the School management Committee. This has to be countered through coordinated efforts of administration, the Education department, the PRI members and the public at large.
- g) Late release of SSA salaries severely impacts the morale and efficiency of the teachers this too adversely affects the regularity/efficiency of the teachers, especially in the outposts.
- h) Low enrolment in the outposts has led to a situation wherein there is extremely excess enrolment in the schools in Seppa.
- i) Shortage of infrastructure is a perennial problem of the schools especially in the schools of Seppa which sees excess enrolment but no corresponding expansion of infrastructure.
- j) Even the basic requirement of furniture has not been attended to. There has been no sanction of fund in this respect for the last five years.
