

MULTI-SECTORAL DEVELOPMENT PROGRAMME

(MINUTES OF THE DISTRICT LEVEL REVIEW MEETING HELD ON 09/03/2015.)

A District Level Committee Meeting was held on 9th March' 2015 at 12.00 Noon in the office chamber of the Deputy Commissioner, East Kameng District, Seppa under the Chairmanship of Sandeep Kr. Singh, IAS, Deputy Commissioner, Seppa to review the various on going projects under MsDP in the East Kameng District.

The member present in the meeting is enclosed at **Annexure "A"**.

While welcoming the members present in the meeting, the Chairman has invited Er. Takar Tachang, DD(UD & Housing) and asked him to give power point Presentation on the projects taken up by his Department. Through power point presentation, DD has explained thoroughly the stages, achievements, progression and over all scope of the two ongoing projects under him as on 9/3/2015. The chairman was satisfied with over all achievement made so far by the Department and added that it needs to accelerate the speed of progress of work in both buildings. He further, directed the DD (UD & Housing) to complete remaining Slab casting work at Bebo cilony School Building and also at least 4 to 5 classrooms in the school Building at Bazarline by end of the May 2015.

Then, the Chairman invited Smti. Pooja Jain, IAS, ADC cum In-charge PD (DRDA) for power point presentation on various schemes undertaken by the Department. She started her presentation with photographs of Construction of 21 Girls Hostel in various schools in the East Kameng District followed by 6 Medical Buildings. All of these are ongoing projects approved during 50th, 53rd & 55th Empowered Committee. The presentation revealed that most of the projects have not been done up to the satisfaction level. In this respect, DDSE and DMO have also shared their views. Taking note of the views of members present in the meeting, the Chairman has directed the concerned Executing Agency/members to carry out the following field exercises:-

1. For on going 6(six) Medical Buildings, The PD (DRDA) and DMO along with site Engineer will form a inspection committee and make physical inspection and verify that whether construction of these six Buildings has followed prescribed Norms of IPHS standard or not. They will submit an inspection report to the Deputy Commissioner latest by 15th April 2015

2. For on going 21(Twenty one) Girls Hostels approved by 55th Empowered Committee, The PD (DRDA), RA (Planning) and Er. Deepak Gyadi (AUPO), DUDA shall make physical inspection of these Girls Hostels and submit an inspection report as per the specifications of Hostels latest by 15th April 2015 for the release of next Installments.
3. The chairman has categorically pointed out that Release of Payment for 2nd installment for all the projects shall be made subjected to the completion of pending works in each project followed by inspection report
4. In the meeting, it has come to the notice that works in the 5 (five) projects approved during 81st Empowered Committee have been started before awarding work orders. Hence, the PD, (DRDA), Seppa is directed to stop the contractors from starting any works before work orders are issued to them.
5. The undersigned has also agreed to forward Quarter progress Reports of all projects against which the 1st Installment payments have already been released to Executing agencies.
6. In addition, the chairman has also made a clear cut direction for two Executing Agencies that the works progress in different projects should be executed strictly as per the design, specification and the scope of the works.

The meeting ended with vote of thank from the Chair.


