will be rejected. Applicant can apply for only one unit in one trade, multiple applications will disqualify the applicant for loan under the scheme.


1. Eligibility criteria

- b) from House Hold within double the BPL income. (Income below Rs. 84000/- per annum)
- c) between age group of 18-50 years
- d) resident of the district where they propose to be set up the project.
- e) without any loan default

2. Preferential criteria

- a) Already functioning unit of Proprietor/Promoter for at least one year in the applied trade within the district.
- b) Proposal Land holding/Possession of land is within identified or within 1 KM radius of existing units.
- c) Cooperative Societies dealing in applied trade project area.
- d) Technically qualified Proprietor/Promoter in related trades.
- e) Individual Women Entrepreneur.


